The City of Albuquerque, Environmental Health Department, Air Quality Division (Division) is responsible for the review and issuance of Air Quality Permits for any source of air contaminants within Bernalillo County. The Division performs a technical review of each application submitted and rules it either complete or incomplete. Once an application is deemed complete, the Division is required to provide at least 45 (but no more than 60) days for public comment on each application. If sufficient comment is received regarding the completed application, the Division may elect to hold a public hearing.

The Division received an Air Quality Permit application from **Smith's Food & Drug Centers, Inc.** to modify their air quality permit for the fuel dispensing station located at 410 Yale Blvd SE in Albuquerque, New Mexico. The Division performed an initial technical review of the application. The Division on October 21, 2011 conducted an evaluation and has ruled the application complete and has assigned this application permit #2154-M1.

Application for Air Quality Certificate of Registration and Authority-to-Construct Permit For Smith's Food & Drug Centers, Inc.

Smith's Food & Drug Centers, Inc. has submitted an authority-to-construct air quality permit application for the modification to their current authority-to-construct air quality permit to the Air Quality Division (Division) of the City of Albuquerque Environmental Health Department to modify the air quality permit for the fuel dispensing station located at 401 Yale Blvd. SE in Albuquerque, New Mexico. Smith's Food & Drug Centers, Inc is requesting to increase gasoline throughput in the air quality permit from 3,405,040 gallons of gasoline per year to 4,500,000 gallons of gasoline per year. The volatile organic compound emissions are estimated to be increasing from 22.13 tons per year to 29.25 tons per which results in an estimated increase of 7.12 tons per year of volatile organic compound emissions. This application file has been assigned Permit #2154-M1. The owner of this fuel dispensing station is Smith's Food & Drug Centers, Inc., 1550 South Redwood Rd., Salt Lake City, Utah, 84116.

The air pollution emissions to the atmosphere from this facility have been estimated to be:
