# City of Albuquerque Gets Green Light for Next Phase Of Bus Rapid Transit Project Development

ABQ Ride notified of federal approval to commence "Project Development Phase"

Albuquerque's Transit Department/ABQ RIDE has received word from the Federal Transit Administration that the city has been authorized to move to the Project Development Phase for *Bus Rapid Transit (BRT)* along Central Avenue. This is an early and critical step in the process of getting BRT to Albuquerque and it opens up the prospect for millions of dollars in federal matching funds for the project. Bus Rapid Transit has a proven record in cities around the world for significantly improving public transportation, creating opportunities for economic growth and spurring transit oriented development. When

compared to light rail systems, Bus Rapid Transit accomplishes many of the same goals but can be built for pennies on the dollar in comparison.

The Bus Rapid Transit proposal is a key component of Mayor Richard J. Berry's overall plan for improving public transportation while creating a more vibrant and energized business environment along Central Avenue, Albuquerque's busiest and most used thoroughfare. Central Avenue accounts for 42% of ABQ RIDE's ridership. The project will result in more timely and convenient transit service to the neighborhoods and businesses along the route. Preliminary research and community outreach has included two rounds of public meetings which were well attended and included good feedback from citizens.

"Project Development represents a critical phase and takes us one step closer to a state-of- the-art transit service for residents of Albuquerque," said Bruce Rizzieri, Director of ABQ Ride. "Coupled with the great work that is going on at the Mid Region Council of Governments centered around additional BRT routes the next generation of transportation looks bright," he added.

"BRT will be a key economic driver for our city which will complement our Innovation District initiatives and result in enhanced opportunities along Central Avenue," said Mayor Richard J. Berry. "This is a great opportunity to make a smart public sector investment that will drive significant private sector activity and job creation."

The Project Development phase will include:

- Continued Public Involvement.
- Conceptual Engineering.
- Potential Impact on Street Operations.
- Environmental Documentation.
- Identification of Historical Properties.
- Mitigation of these Impacts.

#### Some of the hallmarks of BRT are:

- Boarding platforms level with the floor of the bus, easing and speeding the boarding process just like a subway of a light rail transit car.
- Off-bus fare collection enabling riders to purchase tickets outside the bus, reducing waiting time to get on the BRT.
- A smart signal system, allowing BRT to communicate with traffic signals and reducing delays.
- Dedicated lanes for a majority of the route.

The Development Phase is anticipated to take approximately 12 months. The city will continue to hold public meetings to educate the community about BRT and the advantages and cost savings associated with the project. These will be opportunities for the public to learn more about BRT and the important part it can play in the vitality of our city's future.

#### **Door-To-Door Solicitation**

Illegal or unauthorized door-to-door solicitation presents a possible unsafe situation in the residential setting. Individuals who represent themselves as a legitimate business are often times conducting fraudulent or potentially criminal activity. This type of enterprise is less prevalent today so individual citizens should consider any unexpected knock at the door to be potentially suspicious. The following are suggestions about how to create and maintain a safe and secure residential environment and how to handle the unwanted or unauthorized solicitor.

- behavior and activity in their immediate area or block. Citizens should apply this knowledge to persons walking the neighborhood. Strangers or those people that do not belong should be noticed and observed for suspicious activity. If a person's behavior is deemed to be abnormal or suspicious, the citizen should call the non-emergency number 242-COPS. If someone witnesses a crime in progress dial 911.
- should ALWAYS observe the area through a window or eye-viewer prior to opening the door even if they are expecting a visitor. If an unfamiliar person is observed outside the residence the occupant should be very cautious about opening the door. If there is a security screen door with a deadbolt lock in place and the citizen feels comfortable with opening the door they should not engage the individual but rather politely ask them to leave. In the absence of a security screen door they should notify the visitor they are unwelcome and ask them to leave the premises via the locked door and should never allow entry for any reason. Once the person is asked to leave the resident

- should observe them leaving and be prepared to report suspicious activity to the police.
- It is important to note that a knock at the door should not go unanswered in some manner – whether through the security screen door or the main door. Criminals posing as a legitimate solicitor are looking for an empty house to eventually commit residential burglary. If the criminal breaks into an expected empty residence and finds an occupant the probability of a violent encounter is high.
- Home Invasions can be the result of a door-to-door solicitor. The criminal knocks on the door and through a variety of techniques, persuades the resident to open the door. Once the door is open other individuals appear from obscured locations and force their way into the residence. If someone is at the door claiming to require assistance or some type of help, especially late at night, NEVER OPEN THE DOOR – call 911.
- Citizens who have experienced an illegal solicitor or suspicious person should alert other neighbors in the immediate area.
- It is recommended that no one engage or enter into a
  discussion about the purchase of items or services
  from any one who initiate contact with them. If items
  or services are needed citizens should pursue the
  purchase through established businesses. All frauds
  and scams originate from contact initiated by someone
  else
- How to verify a solicitor's legitimacy All legitimate businesses in the City of Albuquerque must have a permit to operate and this includes the door-to-door solicitor per City Ordinance 13-3-1-1. The Ordinance requires the individual to have on their person a permit that can be produced on request, which includes photo identification. Any solicitor that claims not to have one or has left it in another location should be considered illegitimate. If you desire the right of privacy, posting a No Trespassing or No Soliciting sign on your premises must be observed by the solicitor. Solicitation is permitted only between the hours of 9 a.m. and sunset.

# ABQ RIDE Modifies A Route Due to Paseo Construction, Moves to Put More Books in Kids' Hands and Asks for Public Comment from Sun Van Passengers

On Monday, March 3, 2014, ABQ RIDE began a modification of its Route #251 (ABQ-Rio Rancho/Rail Runner Connection), due to the ongoing Paseo del Norte/Jefferson construction. The route is now starting one of its afternoon, north/westbound runs five minutes early, to ensure that passengers make their Rail Runner connection on time.

The #251 will now be leaving the New Mexico Rail Runner's Los Ranchos/Journal Center Station at 4:55 p.m. on a route that eventually loops back to the station by 5:26 p.m. This ensures that passengers on #251 will be on time for the Rail Runner's southbound #515 train, which is scheduled to leave the Los Ranchos/Journal Center Station at 4:55 p.m. on a route that eventually loops back to the station by 5:26 p.m. This ensures that passengers on #251 will be on time for the Rail Runner's southbound #515 train, which is scheduled to leave the Los Ranchos/Journal Center Station at 5:34 p.m. The schedule for the rest of the trip from the station to the west side will not change.

ABQ RIDE is making the modification because of continuing traffic congestion at the Paseo del Norte/Jefferson intersection. Road work near that intersection is ongoing as part of the reconstruction of the Paseo del Norte/I-25 interchange.

This schedule change to the #251 will remain in effect until construction of the new interchange is completed.

On February 15, ABQ RIDE reprised a program to put more books in the hands of kids with its *Discover A Book* Program, part of the City of Albuquerque's "Read to Me" Book Drive.

For the past eight years, ABQ RIDE has been placing books on its buses; for children and even adults to read and take home. The program, called *Discover a Book*, is an annual part of the Albuquerque Business Education Compact (ABEC) and the City of Albuquerque's *Read to Me* Book Drive. On February 15, these groups are once again looking for donations of books, especially children's books.

"We put some of these books on ABQ RIDE buses, hoping a child might read one or more and eventually take them home," said Bruce Rizzieri, Director of ABQ RIDE. "It makes taking public transit a more meaningful experience, especially for children."

This year's *Read to Me* Book Drive runs through Monday, March 31, 2014. Individuals, groups and businesses are invited to participate in collecting books, especially children's books for the programs. *Read to Me* Book Drive collection sites are at the following metro Albuquerque locations: *Barnes and Noble, John Brooks Supermarts, Applebee's, La Montanita Coops, Albuquerque/Bernalillo County Library System* and *Village Inns*. Nearly 50 local employers will also conduct *Read to Me* book drives among their employees and patrons.

The goal is to collect 45 thousand new or gently-used books (from toddler through middle school level) and distribute them to children from low income families. The *Read to Me* Book Drive, through the collection and donation of books to children, builds a foundation for developing literacy skills.

ABQ RIDE is also considering updates to its process for certifying Sun Van passengers. And it wants the public's comments on proposals.

#### Public Input Opportunity on BioPark Master Plan

Next Information Session scheduled for March 20th

The ABQ BioPark (Aquarium, Botanic Garden, Zoo and Tingley Beach) is a cultural treasure visited by more than 1.2 million residents and visitors each year, earning it the position as the most visited public attraction in New Mexico. With a view to the future, city leaders, staff and other experts are drafting a Master Plan to help ensure that the BioPark will remain a viable and valuable asset to the community well into the future.

To ensure that the plan meets the needs and wishes of both residents and visitors—for the near and long term—the City of Albuquerque is hosting the next public information session on the Master Plan process Thursday, March 20<sup>th</sup> from 5:30 p.m. to 7 p.m. at the Barelas Senior Center (714 7th St SW, 87102). This is the second of three sessions. The time and date for the final session has not yet been determined.

Included in the session will be an introduction to the team members who are leading the Master Plan process: Albuquerque based NCA Architects and Jones and Jones Architects of Seattle, Washington. City staff will also participate. A presentation by the consultant team will include discussion on what has been learned since the initial phase of the project. A question/answer session will welcome input from the public.

## **Help Is Here For Your Pets...**

It has never been easier to have your pet spayed or neutered and it's one of the most important steps you can take as a responsible pet owner.

Every year, thousands of unwanted dogs and cats are born because people did not spay or neuter their pets. There are simply not enough homes for the animals that are born because of this type of neglect.

The city Animal Welfare Department is offering surgeries at no charge for the pets of low income and moderate income Albuquerque residents. 
The Animal Welfare Department also works with programs that can arrange for the **FREE** spay or neuter of street cats in your neighborhood to humanely control the cat population. For information, contact Best Friends Animal Society, **505-440-3441**.

Spaying and neutering provide health benefits in addition to preventing litters. Spaying helps prevent uterine infection and breast cancer which is fatal in about 50 percent of dogs and 90 percent of cats. Neutering can prevent testicular cancer if done before six months of age. Neutering also reduces roaming and nuisances such as foul odors in spraying by cats. It can reduce aggressiveness and fighting among both dogs and cats.

Under most circumstances it is against the law in Albuquerque to own a dog or cat that is not spayed or neutered.

The Animal Welfare Department has been working hard to upgrade important services such as the spay/neuter programs, while also improving the results at city animal shelters. Euthanasia during 2013 was down 54 percent compared to only two years ago.

Improvements at city shelters have included greater success with adoptions, vigorous efforts to place animals with rescue groups, much better use of marketing and special events, improved efforts to ensure the quality of adoptions and a foster care program that has helped save hundreds of young kittens as well as other animals with special needs.

**Description:** City of Albuquerque Solid Waste Residential Customers can take advantage of **FREE** green waste pickup. Green waste will be collected on your regular trash collection day during the following weeks:



- April 28 May 2
- May 5 May 9

**Instructions:** Solid Waste Residential customers must place green waste - such as leaves, grass and brush - in trash bags.

- Bags must not weigh more than 40 pounds each.
- Branches must be cut to four foot lengths and bundled securely.
- Items for green recycling must be placed at the curb for collection by 7 a.m. on the regular trash pickup day.
- Items should be placed five feet away from automated trash containers.

**Prohibited Items:** Collection crews won't pick up the following items:

- Dirt.
- · Construction Debris.
- Gravel.
- · Construction Material.
- Tree Stumps.



Save My Spot at AHA. If you are currently on our multiple year long waiting list for admission to our rental assistance programs, you will be receiving an update request form by U.S. mail very soon at the home address of record you gave AHA when you first applied or to the most recent address you have provided to AHA. This update form is a chance for you to list changes that have occurred in your household since you first applied (i.e., added people, got a job, change in mailing address, kids moved out, etc.). Currently, there are about 5,667 households in line currently for an AHA Section 8 Housing Choice Voucher and about 3,341 households in line for a Public Housing unit. Even if there are no changes in your information you must sign the AHA form and then return it to the AHA office by the deadline, if you want to remain on the waiting list for another year. If you take no action you will be dropped from the list automatically.

Please return the update request form to the AHA office by March 14, 2014. If your form is not returned by then you will be sent a second notice, by Certified U.S. Mail. The final deadline for the applicant to return their signed update request form to the AHA office at 1840 University Boulevard SE is April 14, 2014 before 4 p.m. to stay on the waiting list. #### Amending a Main Motion...Procedure will be covered in "Smart Meetings"

"To Modify is to Amend"

The subsidiary motion to *Amend* is a motion to modify the wording — and within certain limits the meaning — of a pending motion before the pending motion is acted upon.

*Amend* is probably the most widely used of the subsidiary motions, although the full procedure for its most effective application is not generally well understood by the meeting-going public at large. [RONR (11th Edition), p. 130]

Rules for the use of Amend:

- 1. The amendment must be germane (related to the question being considered).
- 2. Can be applied to any main motion or to any motion that legitimately contains a variable factor.
- 3. Can be applied to an amendment (secondary amendment).
- 4. Is out of order when another has the floor.
- 5. Requires a second.
- 6. Is debatable whenever the motion to which it is applied is debatable.
- 7. Is amendable.
- 8. Debate must be confined to the desirability of the amendment; debate must not extend to the merits of the motion to be amended.
- 9. Only one primary amendment and one secondary amendment are permitted at a time.
- 10. Requires a majority vote.
- 11. May be adopted by unanimous consent.
- 12. To adopt an amendment does not adopt the motion being amended.
- 13. May be reconsidered.
- 14. If the amendment is adopted by majority vote (or unanimous consent), then the main motion as amended must be voted on and can be adopted or can fail.

A main motion can be amended by:

Adding at the end. The maker of the amendment would state, "I move to amend the main
motion by adding"
Striking out a word or words. The maker of the amendment would state, "I move to amend the main motion by striking
out (stating the specific words to be stricken)"
Inserting a word or words. The maker of the amendment would state, "I move to amend the main motion by inserting
after and before"
Striking out and inserting a word or words. The maker of the amendment would state specifically what word(s) is to be
stricken and what words are to be inserted in that place.
Substitution (paragraph or entire motion).

Amendments can become confusing if the presider is not familiar with the procedure. So... now it might be more clear as to why the December column emphasized that it is very important to write a motion and be sure that it contains all necessary information...before presenting it!
