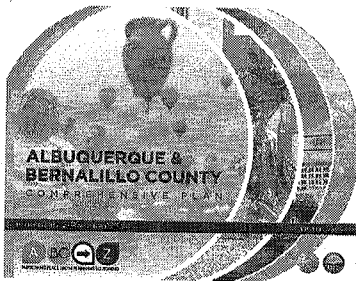

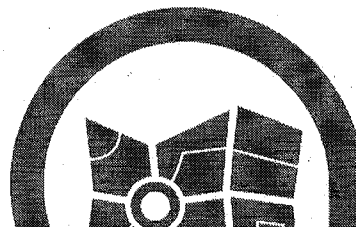
The revised chapter narratives will be posted on the project webpage by **Friday, April 8**. We hope to post revised policies for each content chapter on or immediately following **April 15**.

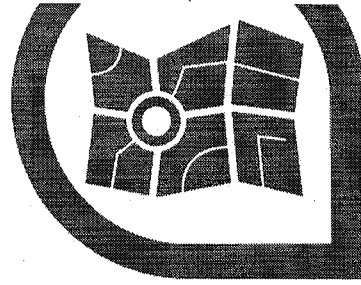
